Objectives

The course aims to provide students with an understanding of the general concepts and fundamental themes of political sociology, contributing to a solid foundation in Political Sociology. Particular attention will be given to political communication, with a specific focus on the role and function of political language and propaganda as factors influencing opinion processes and the construction of political identities at the core of civil society.

Prerequisites for admission

Basic knowledge of General Sociology and contemporary history is presumed.

Course structure

The course in Sociology of Political Phenomena has the following learning objectives:

- Explain and define the basic concepts of Political Society: State, Power.
- Present the fundamental theories on the distribution of power: Elitism, Pluralism, Democracy, Totalitarianism.
- Illustrate the dynamic analysis of political socialization processes, political culture, and processes of political participation.
- Explain the concept of democratic quality and its fundamental components.
- Illustrate the mechanisms of political communication.



Competencies

A. Knowledge and understanding:

The expected outcomes of the course include the development of analytical skills necessary to understand and internalize the mechanisms underlying politically significant phenomena. In this regard, the course enables the acquisition of knowledge related to topics concerning the social dimensions of political phenomena and fosters the sensitivity required to identify political and social issues characteristic of contemporary societies.

B. Applying knowledge and understanding:

Students must demonstrate the ability to professionally apply the topics covered in the course, particularly in the analysis of situations related to the typical processes of power relations in the political field. They should identify potential connections between various areas of disciplinary knowledge and their application to political practices, developing an appropriate analytical profile and reflective capacity regarding participatory and communicative practices in politics.

C. Making judgements:

Students should be able to apply the acquired knowledge to develop analyses that are as original as possible and to process analytical data for defining systemic or specific scenarios, contexts, or climates.

D. Communication skills:

Students must acquire an appropriate disciplinary vocabulary and be capable of articulating it through various communication channels, considering the need to communicate clearly and thoroughly with specialists in the field while also effectively addressing non-specialists.

E. Learning skills:

Students must be able to apply the knowledge and skills acquired throughout the course in an integrated manner, complementing it with instruction provided in other courses of the study program. Additionally, they should develop methodological skills that enable them to independently pursue new learning paths in the field of Political Sociology.
