The course aims to provide the main concepts, tools, theoretical and methodological approaches of intelligence in light of the changes in society and threats to security.

Course structure

The course of Intelligence and Social Change has the following disciplinary educational objectives resulting from the specific objectives of the course of study:

Definition of the main concepts of the discipline

Exposition of the main elements of intelligence applied to the analysis of social change

Illustration of the development of the discipline and the related threats to security

Application of the tools acquired for the analysis of the post-Covid scenery.

Competencies
